***YILLIK: Annual of Istanbul Studies* Publishing Ethics and Peer Review Statement**

YILLIK: Annual of Istanbul Studies, the open-access and peer-reviewed journal (ISSN: 2687-5012 / e-ISSN: 2687-5691) published by the Istanbul Research Institute on behalf of the Suna and İnan Kıraç Foundation, adheres to the highest standards of peer-reviewed and ethical publishing and research integrity. Editors of the journal follow the principles laid out by the [Committee on Publication Ethics](#).

Authors

Authors of articles published in *YILLIK: Annual of Istanbul Studies* should take public responsibility for the work they have put in the publication. The research integrity manifested in these articles is of utmost importance. Authors who submit their research to *YILLIK* must be honest and transparent to their research subjects as well as to the editors of the journal. Their research must be thorough to the best of their ability. Any potential conflict of interest between the author and subject matter must be disclosed with the submission of the article. By submitting their articles for publication, the authors pledge that their articles have not been previously published in any language or format, and that, if selected, their articles would be featured in *YILLIK: Annual of Istanbul Studies* as original works. Authors are responsible for submitting their work with full citations, in accordance with the Chicago Manual of Style's most recent edition and the style [guide](#) of the journal. After submission, they must engage in the peer review process fully, responding to the feedback by the reviewers and the editors. Authors are responsible for clearing the necessary reproduction rights for any images, photos, figures, music, data, or other content credited to a third party. Corresponding authors must also be transparent about the role of other authors and contributors. Those who make substantial contributions to research and/or writing of the article, who draft or substantially revise the written piece should be considered as co-authors and must approve the version to be published. Contributors who do not meet the criteria for authorship should be cited in the acknowledgments. *YILLIK's* [online version](#) is affiliated with ORCID to provide transparency for authorship. Contributors who are not cited in the article must write to the journal's editor via istanbulstudies@iae.org.tr. If our investigation finds the claimant to be valid, this would be deemed as a serious academic misconduct on the part of the corresponding author and would result in a retraction. There are no publishing fees.

Editors

[Editors](#) of *YILLIK: Annual of Istanbul Studies* evaluate manuscripts based on their scholarly quality and relevance to the journal, and does not discriminate on the basis of authors' race, gender, sexual

orientation, ethnicity, nationality, religion, political or institutional affiliation. However, the journal holds the right to reject manuscripts that discriminate based on the above or which they deem against the journal's values. Editors are responsible for ensuring diversity, equity and inclusion and addressing any concerns prior to publication. *YILLIK: Annual of Istanbul Studies* is an independent journal, without any institutional ties to governments, universities, or multinational publishing conglomerates; hence, decisions to publish are determined solely by the journal's editors who commit to editorial independence and research excellence. The work of *YILLIK*'s editors is overseen by the journal's diverse (in terms of geography, gender, institution, and discipline) and erudite [Advisory Board](#), who regularly meet to discuss the past and future volumes of *YILLIK*, to provide feedback, criticism, and possible publishing orientations for the Editorial Board.

Peer Review

YILLIK: Annual of Istanbul Studies conducts a double-blind peer review process with two experts reviewing each manuscript. Articles submitted for publication in the journal are first evaluated by the editors of the journal, or by the editors of the respective issue. Articles deemed suitable by editors in terms of subject matter and scholarly quality are sent anonymously to two separate reviewers elected according to their expertise. The diverse and erudite Advisory Board members provide the initial pool of reviewers but depending on their availability and the subject/discipline of the article, outside reviewers may also be consulted. Selected peer reviewers have to complete our special Review Form as they prepare their evaluations. Reports from the double-blind reviewers are combined with the comments of the editors and sent back to the author. Depending on academic quality and relevance, articles may be accepted or rejected, or the author may be asked to revise the work. Selected reviewers sign the review form, which informs the editors that they do not recognize the identity of the reviewed article's author and they do not have any conflict of interest, according to the best of their knowledge. The publication decision of peer-reviewed manuscripts lies with the Editorial Board based on the double-blind reports of the peer reviewers. While the Editorial Board has the final say in which articles are published, the recommendation of one reviewer is the minimum criterium for publication. Other types of work, including editorials, Meclis papers, Cabinet essays, and book and exhibition reviews, are evaluated by the Editorial Board. The authors have the right to appeal to the journal's decision and/or peer reviewers' evaluation, in which case the editors reach out to another reviewer, with no conflict of interest with the authors, to provide a new evaluation for the submitted work. Submissions that are rejected by editorial decision without being sent to reviewers due to demonstrable lack of quality or relevance to *Istanbul Studies* cannot appeal, however, the authors are encouraged to resubmit their work with necessary revisions recommended by the editors.

We acknowledge the work of peer reviewers to be essential but equally invisible; thus, we provide a small compensation for their contribution

to the scientific standards we set in *YILLIK*. For more details on proper conduct during the peer review process, please see COPE's Ethical Guidelines for Peer Reviewers [document](#) that we endorse fully.

Research with Humans and Animals

In certain required cases, authors must provide the approval of relevant ethics committees for their research with humans and animals. Participants' right to privacy should be protected and in necessary cases, subjects' written consent for publication should be provided.

Statement of Diversity, Inclusion, and Belonging

We do not discriminate on the basis of authors' race, gender, sexual orientation, ethnicity, nationality, religion, political or institutional affiliation. We invite submissions which engage with diverse perspectives and foster a wide range of approaches from scholars in various fields. We ensure a fair, inclusive practice through our double-blind peer-review process.

Confidentiality

No information about a submitted manuscript is disclosed to anyone other than the author(s), reviewers, potential reviewers, and the members of the Advisory Board, as appropriate. Peer review reports may be occasionally shared with editors of scholarly indexes in order to meet their quality requirements.

Plagiarism

We have zero-tolerance for plagiarism or self-plagiarism. No text, figure, table, or idea may be reproduced from published or unpublished materials without proper citations and acknowledgment. We do check articles for plagiarism and those that contain full or partial plagiarism are rejected outright. If a case of plagiarism is found after the publication, the article will be retracted.

Duplicate Publication

YILLIK: Annual of Istanbul Studies does not publish articles that have been previously published or considered elsewhere, even if in the form of a translation. Authors must declare that their submitted articles are not in consideration for any other publication. Authors need to demonstrate a significant necessity and major improvements if they would like to reuse some of their previously published material; they must cite accordingly and be transparent about the process. Authors, as the owners of their work and in accordance with our open access policy, do have a right to republish their *YILLIK* article in other venues, as long as they cite the original publication properly. They may also upload their *YILLIK* article to their personal websites, academic and institutional repositories, social media platforms, etc.

Addressing Unethical Behavior

Authors and editors of *YILLIK: Annual of Istanbul Studies* must adhere to the publishing ethics outlined here. Plagiarism, falsification/fabrication of authorship or research, duplicate publication, and peer review manipulation are regarded as severe cases of misconduct and would be dealt with accordingly, including but not limited to retractions. If authors feel that their manuscript is

unfairly evaluated by the reviewers or the responsible editor, they are encouraged to directly contact the journal's editor via istanbulstudies@iae.org.tr. In this context, the editor would provide their own evaluation, send the article to a third reviewer, and if the circumstances require, might form an independent committee among the members of the Advisory Board to address author's claims. In all these cases, we follow COPE's guidelines.

Retractions and Corrections

Articles that are found to have serious misconduct (plagiarism, data fabrication, dishonest behavior towards research subjects, authorship disputes, etc.) after the publication will be retracted. Authorial errors in published articles will result in corrigenda, and editorial errors will result in errata in future volumes of the journal as well as on its website.

Open Access Policy

YILLIK: Annual of Istanbul Studies is published online and in print. Both editions have the exact same content and there is no embargo period. The online edition is open access. Publishing in *YILLIK* is free of charge. Authors of articles published remain the copyright holders and grant third parties the right to use, reproduce, and share the article according to the [Creative Commons](#) license agreement upon proper citation and acknowledgment of the original publication.

Archiving

The journal is published both in print and digital formats. The digital format is hosted in the [DergiPark](#) platform, where the entire archive of the journal can also be accessed.

Revenue Formats and Advertisements

Istanbul Research Institute is a non-profit affiliate of the Suna and İnan Kır   Foundation. The journal is supported by the individual sales of the print edition (the digital edition is open access) and subscriptions but mostly through the generous endowments of the Foundation. The journal does not include any advertisements apart from announcements of its own projects, including exhibitions or other publications.
